# Discussion concerning the purchase of a Fire Tanker

The Town Manager explained to the Board of the Fire Departments need for a Fire Tanker to replace the current tanker which is over 25 years old. The Town Manager outlined two methods that could be used to purchase the vehicle. Methods discussed included General Obligation Bonding and Leasing. The Board of Selectmen while in support of the purchase of the vehicle were concerned that the process spelled out in the Procurement Ordinance requiring the Procurement Officer to request bids from suppliers needed to be followed. The Town Manager stated that the Procurement Ordinance did provide some discretion on the area of sole source procurement. The Selectmen requested that the Ad Hoc Fire Vehicle Committee reconvene to develop general vehicle specifications and obtain bids.

No formal action was taken and none would be taken until the Ad Hoc Committee has met and a positive recommendation developed.
